2. Issue notice to the fourth respondent returnable by 09.09.2026. Private notice is also permitted.

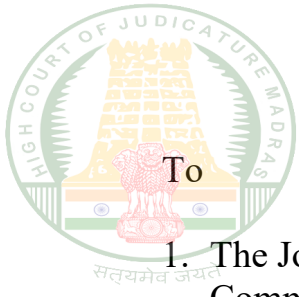
