2. Accordingly, the Registry is directed to issue a fresh order copy in CRP.No.4041 of 2025 dated 26.08.2025 after making necessary corrections.

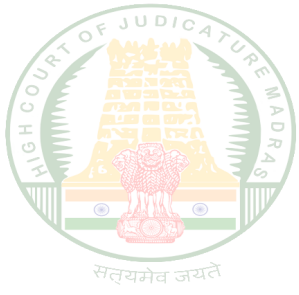

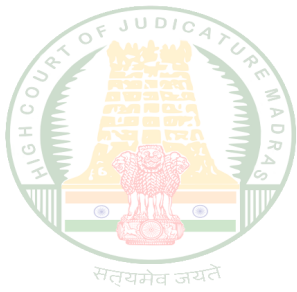

ORDER

The revision petitioner seeks expeditious disposal of O.S.No.146 of 2011 which has been re-numbered as O.S.No.218 of 2012 before the District Munsif Court, Karur.

2. The revision petitioner is the plaintiff and the suit has been filed for declaring the easmentary right of the plaintiff and also for permanent

injunction to restrain the defendants from interfering with the plaintiff's peaceful possession and enjoyment of the suit property. I find that the pleadings are complete and the trial Court has been adjourning the matter citing the pendency of the interlocutory applications for the past several years. In view of the fact that the suit is posted for trial and that the issues have already been framed even as early as in January 2021 and that the trial is yet to commence, I am inclined to allow this revision and direct the learned District Munsif Judge, Harur, to expedite the trial in the said suit and dispose of the same on merits and in accordance with law on or before 31.01.2026.

3. Accordingly, this Civil Revision Petition is disposed of. There shall be no order as to costs.

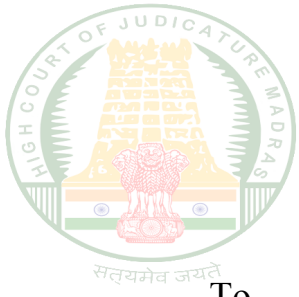

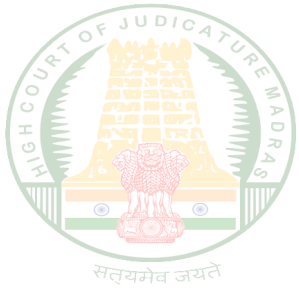
