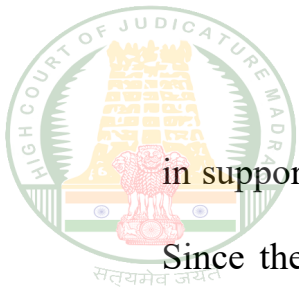

ORDER

in support of this writ petition, which the petitioner claims that he is the owner.

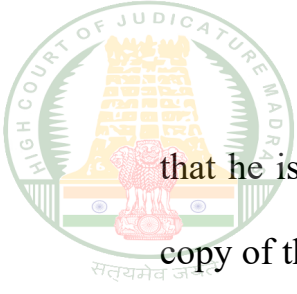
Since the representation has not been considered, the petitioner has filed this writ petition.
