(ii) pass an order of Interim stay of all further proceedings
pursuant to the proceedings of the 1st Respondent in Na.Ka. No.1-
20584/ 2017, dated 23.11.2017 (in WMP.36418/017) pending WP
No.33041/2017 respectively.
