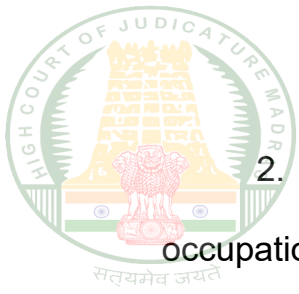

ORDER

(Order of the Court was made by S.M.Subramaniam J.)

Form-B order passed under Section 248 of Pondicherry Village and
Commune Panchayats Act, 1973, is under challenge in the present writ
proceedings.



2. The petitioner is identified as an encroacher. He is in unauthorized occupation of Government promboke, Vaikkal land, Ammachi Kulam, i.e., water body. Thus, the order under section 248 came to be issued.

3. Since the order was issued in the year 2022, this Court is inclined to grant one more opportunity to the petitioner to submit his representation along with the documents if any, to the authorities, within a period of ten days from the date of receipt of a copy of this order. If any such representation is submitted, the same shall be considered by the respondents and thereafter, proceed with the enforcement action for removal of encroachment in the water body if any, without causing any undue delay. The entire exercise is directed to be completed within a period of twelve weeks from the date of receipt of a copy of this order.

4. With the above direction, the Writ Petition is disposed of. No costs. Consequently connected miscellaneous petition is closed.
