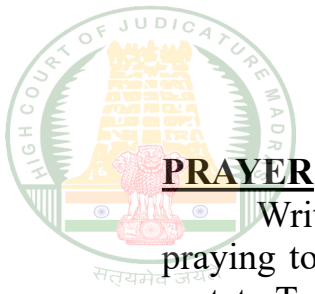

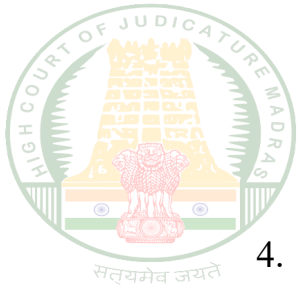

ORDER

This writ petition has been filed to direct the third respondent herein to mutate Town survey Register with respect to Town Survey Nos.9,11 and 12 at Block C at Tiruchengode Taluk and Town Namakkal District in the light of the order dated 6.4.2015 in Na.Ka.No.92/2014 issued by the third respondent herein.

2. On perusal of records, it appears that this matter has already been posted for hearing on 09.03.2026, however, there was no representation on behalf of the petitioner. Hence, today, this case is listed under the caption “For Dismissal”.

3. Today also, there is no representation for the petitioner, which shows that the petitioner has no interest to prosecute the present case. Hence, this Court is inclined to dismiss this petition.



4. At this juncture, the learned Senior counsel appearing for the 4th respondent had brought to the knowledge of this Court that initially, the present writ petition was allowed vide order dated 28.11.2024 and subsequently, the said order was recalled on 29.01.2025, based on the false statement made by the petitioner.

5. In view of the above, this petition is dismissed for non-prosecution. No costs. Further, it is made clear that in future, if any application is filed by the petitioner for restoration of the present petition, the same shall be entertained by the Registry upon payment of cost of Rs.25,000/- to the Tamil Nadu Legal Services Authority, Chennai.

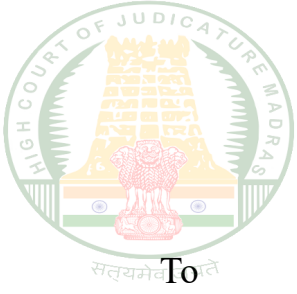
