5. For appearance of the fourth respondent, list the matter on 30.09.2026.

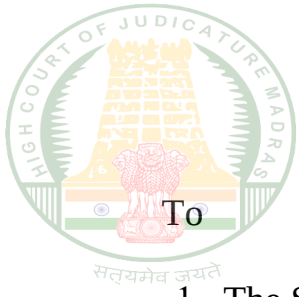
