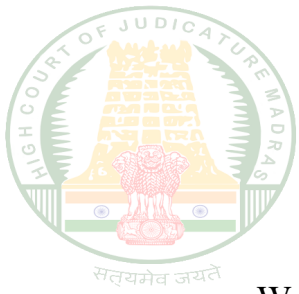

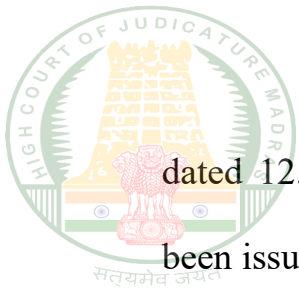

ORDER

This Writ Petition has been filed seeking a direction to the respondent to consider the petitioner's application dated 09.03.2022 and 31.01.2024 and consequently direct the respondents to conduct the Survey in Survey Nos.377/4B1, New Survey No.377/4B1B at Paramanthal Village, Chengam Taluk, Tiruvannamalai District and demark the same.

2. From the records, it is seen that this Writ Petition was already disposed of by this Court on 12.12.2024 with a direction to the 3rd respondent to conduct survey in respect of the subject property, after issuing notice to the adjacent land owners and interested parties. Thereafter, by an order dated 07.01.2026, the 6th respondent herein was *suo motu* impleaded in this Writ Petition and the order



dated 12.12.2024 was recalled for the reason that the 6th respondent had not been issued with notice as ordered by this Court on 12.12.2024.

3. When the matter is taken up for hearing, the learned counsel appearing for the 6th respondent would submit that with regard to the subject property, a Civil Suit has been filed by him in O.S.No.227 of 2018 on the file of District Munsif Court, Chengam, for permanent injunction against the petitioner and interim injunction was also granted in the said Suit and the same is pending.

4. Heard both sides. Perused the records.

5. In the present case, a Civil Suit has been filed by the 6th respondent with regard to the subject property before the District Munsif Court, Chengam in O.S.No.227 of 2018 and interim injunction was also granted and the said suit is pending. That apart, Advocate Commissioner was already appointed by the Civil Court for inspection and measurement of the subject property. Such being the case, no direction can be issued in this writ petition with respect to the survey of the subject property and the petitioner can only redress his grievance before this civil Court.

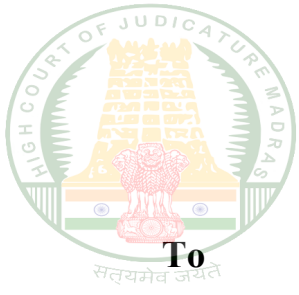


6. In such view of the matter, this Writ Petition is disposed of with liberty to the petitioner to agitate his rights before the Civil Court. No costs.
