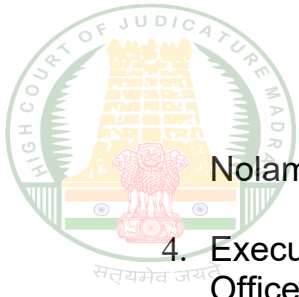
Commissioner, Greater Chennai Corporation/7th respondent is directed to conduct a field inspection by a competent authority and submit a report regarding inspection.
