ORDER

The captioned Civil Miscellaneous Petition is preferred praying to stay all further proceedings in pursuant to the Judgment and order dated 21.03.2025 made in MCOP No.135/2020 on the file of the Motor Accident Claims Tribunal, Dharmapuri.

2. The learned counsel for the petitioner/appellant submitted that the Tribunal has erroneously applied multiplier of 18 and fixed the notional income of Rs.7,000/- for a minor child aged 15 years, which is excessive and resulted in exorbitant compensation of Rs.15,12,000/-. He further

submitted that the appellant is ready to deposit the entire award amount and

prays for staying of further proceedings in the above case.

3. Considering the submissions made by the learned counsel for the petitioner/appellant, an interim stay is granted on a condition that the petitioner/appellant shall deposit the entire award amount to the credit of MCOP No.135/2020 on the file of the Motor Accident Claims Tribunal, Dharmapuri, on or before 19.01.2026, failing which the interim stay shall automatically stand cancelled without reference to this Court. On such deposit, the claimants are permitted to withdraw 50% of the award amount deposited to the credit of MCOP No.135 of 2020.

4. Post the matter on 20.01.2026 for reporting compliance. Notice to the respondents by then. Private notice is also permitted.
