Order

After hearing both sides briefly, this matter is referred to Mediation. All permissible modes of notice are permitted.

2. The parties are directed to appear before the Tamil Nadu Mediation and Conciliation Centre, High Court of Madras, Chennai along with their child directly on 02.04.2026.

3. The Mediator namely Mrs.R.Rathna thara along with Ms.Manimegalai, child Counsellor, shall hold appropriate sessions with the parties, explore the



possibility of an amicable settlement of the inter se disputes, and facilitate the parties in arriving at a mutually acceptable resolution. In the event of a settlement being arrived at completion report shall be submitted before this Court.

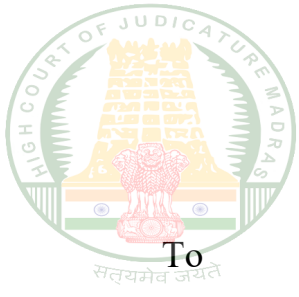
4.If no settlement is arrived at between the parties, the Child Counsellor shall submit to this Court a report setting out a feasible parenting plan, bearing in mind the paramount welfare of the child/children. The fees and expenses of the counsellor shall be borne by the parties.
