COMMON ORDER

Challenging the findings of the courts below, the original defendant has preferred an appeal and it was at SR stage AS SR. No.17275 of 2022. With regard to implead, the legal heirs of the deceased first respondent filed a petition



before the trial court and it was dismissed, which is under challenge.

2. The learned counsel submits that still they are having valid defence to prove their case in the appeal suit. In such circumstances, if the Execution Petition is executed, it would lead the multiple proceedings and put great hardship to the petitioner. Hence, EP No.3241 of 2015 is ordered to be stayed. Post the matter for reply of the respondents finally on 15.04.2026.

3. The impugned order passed by the trial judge in IA Nos.2, 3 and 4 of 2024 in AS.SR.No.17275 of 2022 on the file of the I Additional Judge, City Civil Court, Chennai, is ordered to be stayed.
