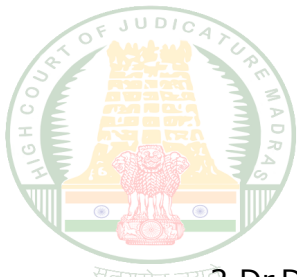

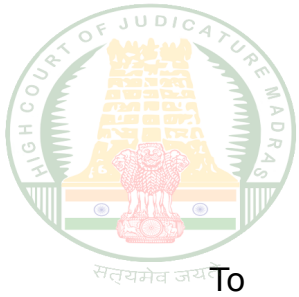
JUDGMENT

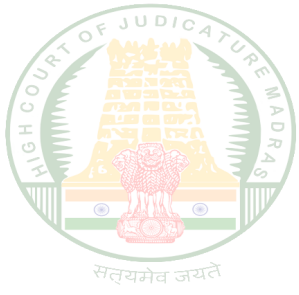
