To permit the applicant/petitioner to accompany the minor daughter S.Samritha for all the academic and other necessary activities and direct the respondent to include the applicant/petitioner in all such activities pending disposal of the OP.

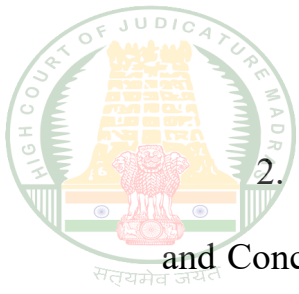

Order

After hearing both sides briefly, this matter is referred to Mediation. All permissible modes of notice are permitted.



2. The parties are directed to appear before the Tamil Nadu Mediation and Conciliation Centre, High Court of Madras, Chennai along with their child directly on 06.04.2026.

3. The Mediator namely Mrs.G.Sridevi along with Ms.Neha Murali child counsellor, shall hold appropriate sessions with the parties, explore the possibility of an amicable settlement of the inter se disputes and facilitate the parties in arriving at a mutually acceptable resolution. In the event of a settlement being arrived at completion report shall be submitted before this Court.

4. If no settlement is arrived at between the parties, the child counsellor shall submit a report before this court setting out a feasible parenting plan bearing in mind the paramount welfare of the child. The fees and expenses of the counsellor shall be borne by the parties.

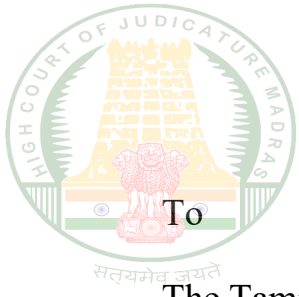
5. Presence of the child before this Court is dispensed with.
