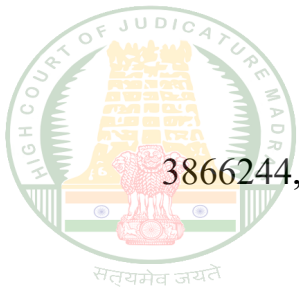

ORDER

This Writ Petition is filed for issuance of a Writ of Mandamus, seeking a direction to the respondents to grant permission to shut out the Cargo / take back the cargo to town and to release the goods comprising 28,500.00 Kgs., viz., 1,425 Cartons of Indian Halal Frozen Boneless Buffalo Meat, presented for export vide Shipping Bill No. 3866244, dated 09.09.2024.

2. Today, it is submitted by the learned Senior Standing Counsel for respondents that, subsequent to the filing of the present Writ Petition, orders have been passed. A copy of the same has also been furnished to the learned counsel for petitioner.

3. Learned counsel for petitioner would then request that liberty may be granted to challenge the orders that have been passed.
