2. Shri. Prabakar, on instructions from Tahsildar, Avadi, who is respondent No.3, states that survey has already been conducted to identify the encroachers and the list and details of encroachers have been made available to respondent No.6, Avadi Corporation on 21.02.2025. Mr.Prabakar states now it is respondent No.6 who should initiate action to remove the encroachers.

3. Shri. Gopinath states he has to take instructions to ascertain what steps respondent No.6 has taken pursuant to the letter dated 21.02.2025.

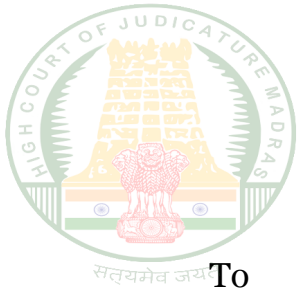
