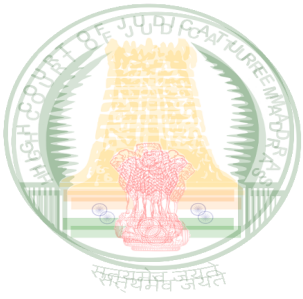

### Order

It is a representation made by the learned counsel appearing for the respondents that the recruitment is for a project based. However, the details of the project is not available either in the notification or in the preliminary Abstract in G.O.(Ms) No.1 Health and Family Welfare (C2) Department, dated 02.01.2012. Even in the letter of the Mission Director dated 03.07.2025 addressed to the Director of Public Health and Preventive Medicine, it has been stated as follows :
