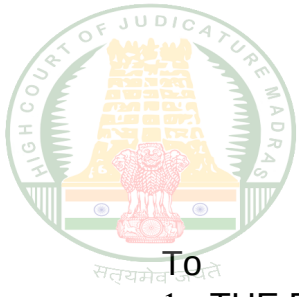
ORDER

This Court by an order dated 02.02.2026 allowed the present Writ Petition and issued a direction to the respondents 2 and 3 to forthwith raise the attachment of the property belonging to the petitioner in Survey No.291/1 admeasuring an extent of 1320 Sq.Ft., Nainarpalayam Village, Chinnasalem Taluk, Kallakurichi District.
