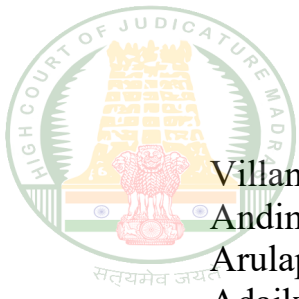

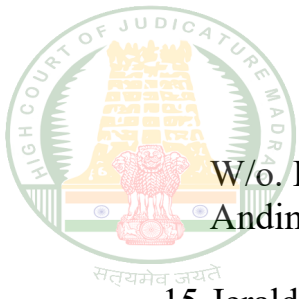

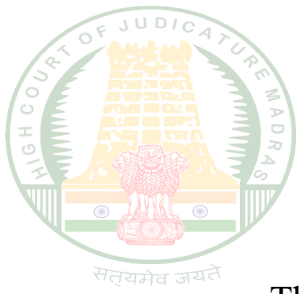

The appellants/plaintiffs filed a suit seeking declaration and injunction.
