Solemnly affirmed:

Q1:Is it correct to state that in OP.No.204/2025 there are four respondents?

A:Yes.

Q2:Is it correct to state that the 1st respondent Geetha Bai is your mother?

A:Yes, it is correct.

Q3:Is it correct to state that the 2nd and 3rd respondents are your sisters?

A:Yes, it is correct.

Q4: Is it correct to state that the 4th respondent is your paternal grandmother?

A:Yes, it is correct.

Q5:You have filed application for probate with regard to the WILL executed by your father R.Raja Kumar?

A:Yes, it is correct.

Q6:In the WILL(Ex.P10) executed by your father your are the executor of the WILL. Is it correct?

A:Yes, it is correct.

Q7:Is it correct to state that your father executed Ex.P10 WILL regarding 1 to 5 properties of the WILL in favour of your mother Geetha Bai?

A:Yes, it is correct.

Q8: I put it to you that your father have property at Chennai as well as at Poraiyar, (Mayavaram District).

A:Yes, my father is having properties at Chennai, Poraiyar, Kidangal and at Mamakudi.

Q9:Whether it is correct to state that the aforesaid properties are the joint family properties and it was obtained by your father by way of partition deed?

A:Yes, it is correct and he also exchanged the properties with his brother by way of exchange deed.

Q10: I put it to you that since those properties are joint family properties your father is familiar with the documents to the property.

A:Yes, it is correct.

Q11:Have you filed any document before this court which was executed by your father by himself?

A:No, we have not filed any such document before this court.

Q12:(Ex.P6 is shown to the witness) I put it to you that Ex.P6 is the settlement deed executed by your father in favour of your mother and it was prepared by document writer Mohan Raj.

A:Yes, it is correct.

Q13: I put it to you that your father is familiar with advocates and document writers since he hold so many properties.

A:Yes, it is correct.

Q14: I put it to you that on the date of execution of Ex.P10 your father was aged 57 years.

A:Yes, it is correct.

Q15: I put it to you that your father died in a Road Accident on 04.10.2024.

A:Yes, it is correct.

Q16: Whether your father died on the spot or after admission in the hospital?

A:My father died on the way to Hospital.

Q17:As per Ex.P20 legal heir certificate his wife, his mother and his three daughters are the legal heirs. Is it correct ?

A:Yes, it is correct.

Q18:Is it correct to state that as per Ex.P10 WILL your father bequeathed his property in favour of your mother and you are the executor of the WILL and he has also referred his three daughters in the WILL?

A:Yes, it is correct.

Q19:I put it to you that your father has never referred his mother Thaivanai Ammal in Ex.P10 WILL.

A:Yes, it is correct.

Q20: I put it to you that in Ex.P6,your mother was given life interest to one shop property.

A:Yes, it is correct. After my sister Shivashankari attain Majority of age she will get that property.

Q21: I put it to you that as per Ex.P10 WILL the entire properties(1 to 5 items of the WILL) bequeathed to your mother Geetha Bai.

A:Yes, it is correct.

Q22: Is it correct to state that Ex.P10 WILL executed by your father at Chennai Kilpauk house ?

A:Yes, it is correct.

Q23:Whether all daughters are married at the time of execution of Ex.P10 WILL?

A:Yes, All are married.

Q24:Is it correct to state that in Door No.11B, Ormes Road, Kilpauk, Chennai-10 house your mother and your father are alone lived?

A:Yes.

Q25: Is it correct to state that at the time of execution of Ex.P10 WILL your father and your mother were alone at Kilpauk house?

A:Yes, I think so. At that time I was at Bangalore.

Q26:Is it correct to state that the 1st attesting witness (G.Ramalingam) of the WILL Ex.P10 is your maternal uncle?

A:Yes, it is correct. He is the younger brother of my mother.

Q27:He is residing at Cuddalore is it correct?

A: Yes, it is correct.

Q28:Is it correct to state that the 2nd attesting witness (Ravichandran) of the WILL Ex.P10 is sister's son of your mother?

A:Yes, He is my aunt Meera Bai's son and Meera Bai is the elder sister of my mother. He is also cousin brother's son of my grandmother Thaivanai Ammal.

Q29: I put it to you that both the attesting witness of Ex.P10 WILL are close relatives of your mother.

A:Yes, They are not only close relatives of my mother they are also close relatives of my grandmother Thaivanai Ammal.

Q30:Do you know whether both the attesting witness are having cordial relationship with Thaivanai Ammal and they used to go to her house?

A:Yes, they are having cordial relationship with Thaivanai Ammal and they

used to go to her house.

Q31:Is it correct to state that your parents and Thaivanai Ammal are residing in the adjacent house?

A: Yes,it is correct.

Q32: I put it to you that Thaivanai Ammal is residing in her elder son R.Muthusamy's house.

A: Yes, it is correct.

Q33:Is it correct to state that there is no cordial relationship between your father Raja Kumar and Muthusamy?

A: Yes, Due to the civil case filed my father against Thaivanai Ammal, Muthusamay and Abhiram but myself and my sisters are having cordial relationship with Muthusamy's family.
