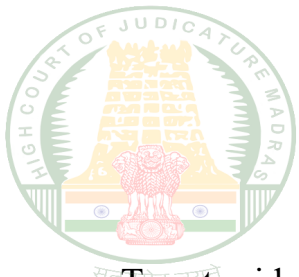

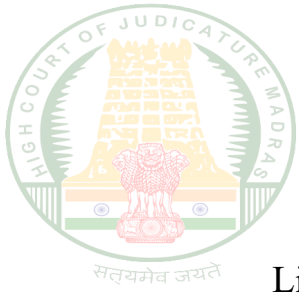

ORDER

This Court by order dated 25.10.2025 directed the petitioners to hand over the possession of portion marked as ABCD in the Advocate Commissioner's report, which was filed pursuant to the orders in CRP No.2989 of 2024. The petitioners were directed to vacate and hand over possession by 21.11.2025. However, today the learned counsel for the petitioners states that the petitioners have gone to Hon'ble Supreme Court, challenging the said order dated 25.10.2025. I find that the SLP has been filed only on 20.11.2025, though the copies were made available even in October 2025 itself. Be that as it may, considering that the SLP has been preferred, the revision may be called for reporting compliance after a period of three weeks.
