2. The petitioner/husband filed a original petition seeking divorce on the ground of cruelty against the respondent/wife. The original petition was filed in the year 2020.

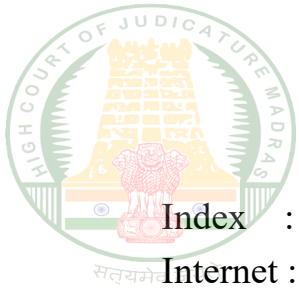
