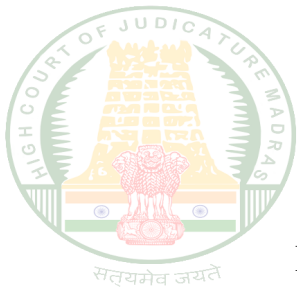

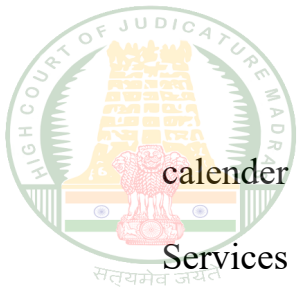

ORDER

Challenging the impugned order passed in I.A.No.2 of 2025 arising out of G.W.O.P.No.48 of 2025 by the learned Principal District Judge, Erode, the Revision Petitioner/Petitioner preferred this Civil Revision Petition.

2. Before the trial court, the Revision Petitioner filed an application under Sec.12 of Guardians and Wards Act, 1890 seeking for visitation right and the same was granted by the trial judge directing to produce the minor child at ADR Building, District Court Complex, Erode, which is far away from the residence of both the petitioner and respondent. Hence, he seeks modification.

3. Admittedly, the child is under the care of respondent mother, who is residing at Gobichettipalayam. Hence he has to travel for more than 100 kms. from Erode, due to which, no purpose would be served. Therefore, the order passed by the Principal District Judge, Erode in I.A.No.2 of 2025 in G.W.O.P.No.48 of 2025 is modified. The respondent mother is directed to produce the minor child viz., J.Hanushree on every first week of English



calender month, which is a working day for the trial court before the Legal Services Authority, Gobichettipalayam and the Revision Petitioner husband is permitted to visit and meet the minor child between 10.30 a.m. to 04.00 p.m..

With the said modification, this Civil Revision Petition stands disposed of.
