Heard the learned counsel for the petitioner and the learned counsel for the respondents 3, 4 and 6.

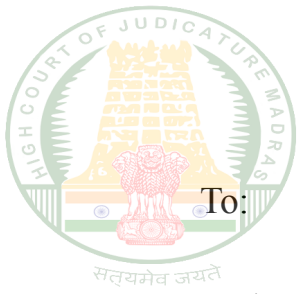
2. The respondents 3, 4 and 6 are directed not to proceed to open the TASMALC, pending further orders.
