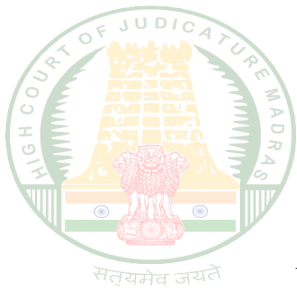

ORDER

The question that arises is whether TASMACH shop No.8730, situated at Survey No.193/2A1C1, Block No.144, Old No.62, New No.55, Jasmine Nagar, Surapattu Madhavaram Taluk, Chennai-600 053 was located within the prohibited limits from the highways. As there is serious dispute over the above issue, this court suggested that an Advocate Commissioner may be present during the survey by the Taluk Surveyor.

2. In view of the above, we appoint Ms.Ashnal S, Advocate (Mobile No.9994986326), having office at No. 319/Old No.155, Lingi Chetty Street, 3rd Floor, George Town, Chennai-600 001, as Advocate Commissioner, to be present during the survey by the Madhavaram Taluk Surveyor, Madhavaram, Chennai-600 053. The Taluk Surveyor shall measure the distance between the Highway and the subject bar as well as the distance between the subject bar and



service road, in the presence of the Advocate Commissioner. Advocate Commissioner would be present during the above exercise, videograph the same, and submit a report before this Court on or before 30.03.2026, which *inter alia* shall include a report by the Taluk Tahsildar. The remuneration for the learned Advocate Commissioner is fixed at Rs.40,000/- (Rupees Forty Thousand only), which is to be paid by the petitioner.
