JUDGMENT

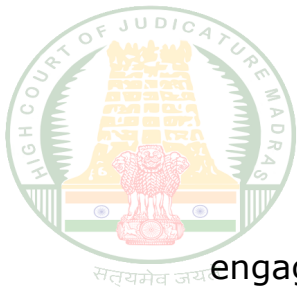
(Judgment of the Court was delivered by

Challenge to the order of learned Single Judge is premised mainly on the submission that respondent was engaged as a Special Public Prosecutor and therefore, his case would not be governed under Slab 'B' of G.O.Ms.No.36 dated 12.01.2011.

2. We find that the successor of respondent was given the benefit of higher remuneration.

3. According to learned counsel for State, the difference of fee would be around Rs.7.5 lakh.

4. Having considered the submission and the amount which is said to be involved, to put a quietus to the dispute in the matter of

engagement of Special Public Prosecutor, we are not inclined to interfere with the impugned order. Let the amount be paid as per the directions of the learned Single Judge within a period of one month from the date of submission of the computation charge.

5. Appeal is dismissed. There shall be no order as to costs. Consequently, the interim application is also dismissed.
