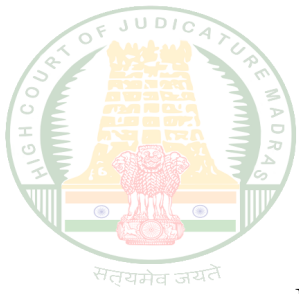

ORDER

Orders of ad interim injunction were granted in O.A.Nos.1069 and 1070 of 2025 on 17.11.2025 restraining the respondent from using the mark NEW SATHYA FURNITURE or any other mark deceptively similar to the plaintiff's registered trade mark SATHIYA. At the hearing on 11.02.2026, the applicant was permitted to call upon social media platforms to deactivate the accounts containing infringing material. Learned counsel for the applicant has filed an affidavit along with documents indicating that the order has not been complied with and that NEW SATHYA FURNITURE is still being used.

2. A representation is made on behalf of Mr.T.Lenin Kumar that the vakalat and relevant documents would be filed on the next hearing date. The respondent is directed to file an affidavit of compliance in relation to orders in force as on date.
