ORDER

The defendant has filed an affidavit dated 24.03.2026 stating *inter alia* as under:

“5. I submit that I have changed the name of my business to “Raja Rani Furniture and Electronics”. The said change has been duly effected in my GST Registration Certificate bearing No.33AZVPR6221L2ZU. I have also removed all physical signboards, printed materials, online listings, and digital advertisements bearing the name “New Sathiya Furniture”.

6. I state that I have taken bona fide steps to ensure that no reference to the earlier name remains in the course of trade, including third-party platforms to the extent within my control. I hereby unequivocally undertake to this Hon’ble Court that I shall not, directly or indirectly, use the name “New Sathiya Furniture” or any other mark/name deceptively similar to the Plaintiffs’ alleged trademark “Sathiya Furniture” in relation to the same or similar goods/business.”

Learned counsel for the plaintiffs has filed memo dated 25.03.2026 stating that the defendant has continued to use the name “NEWSATHIYAFURNITUREEDAPPADI” on social media handle and is still showing the place of business as “NEW SATHIYA FURNITURE”. 3. The defendant shall file a supplementary affidavit on the next date of hearing, after serving a copy thereof in advance on learned counsel for the plaintiffs, stating whether the continued violation of the earlier order of this Court has come to an end, including in respect of specific violations pointed out by the plaintiffs.
