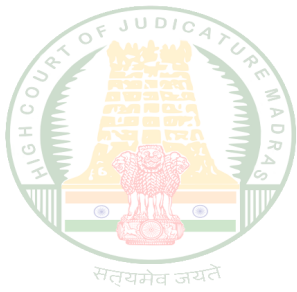

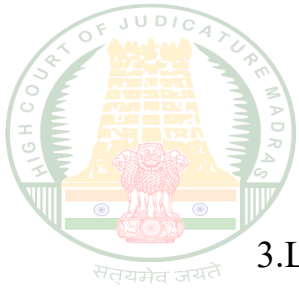

2. There shall be an order of interim stay on condition that the appellant deposits 50% of the respective award amounts together with accrued interests and costs to the credit of each of the LAOP Nos.358 of 2022, 44 of 2023, 307 of 2022 & 368 of 2022, on the file of the Principal District Court at Tiruvallur on or before 15.06.2026. 3.List the matter on 15.06.2026.

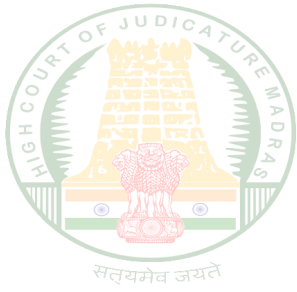
