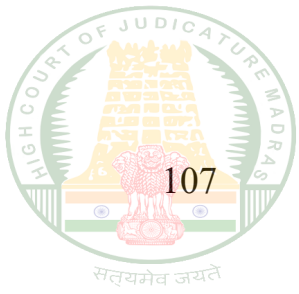

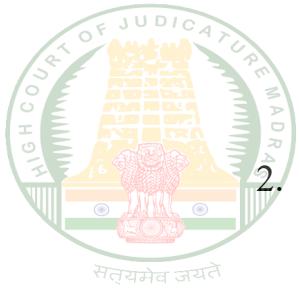

Accordingly, there shall be an order of interim injunction restraining the respondents, their men, agents or any other persons claiming under them from encumbering or alienating the suit schedule property, which is the subject matter in O.S.No.942 of 2022 on the file of the learned III Additional District and Session Judge, Coimbatore.

4. Registry is directed to carry out the necessary corrections and issue order copy afresh. Except for the aforesaid modifications, order dated 17.11.2025, remains unaltered in all other aspects. Registry shall also incorporate the schedule of property since the order of granting interim injunction is in favour of the petitioner.
