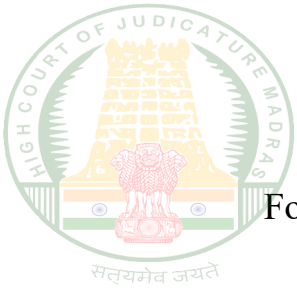

**ORDER**

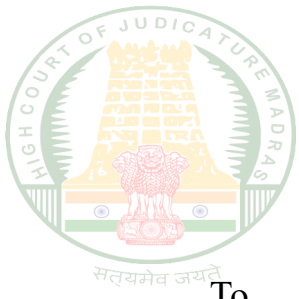
