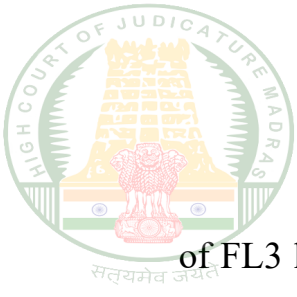

2. The Petitioner is before this Court against the impugned order dated 09.10.2025 bearing Ref.No.Na.Ka.No.1/12920/2025.

3. By the impugned order, the Petitioner's application for renewal

of FL3 license has been rejected on the ground that there is a *inter se* dispute between the Petitioner and the family members at the behest of her daughter viz., H.Rekha who has earlier filed the Writ Petition before this Court in W.P.No.4184 of 2025.

4. It appears that there is also a pending suit filed by the Petitioner's son viz., R.Suresh Babu in O.S.No.3 of 2014 pending before the Additional District Court, Hosur in respect of certain other properties. Since the business carried on by the Petitioner which was also earlier carried on by the Petitioner's late husband viz., V.Raja has to continue, there shall be a direction to the Respondents to give a provisional renewal of the license in Form FL3 forthwith under the provisions of Tamil Nadu Prohibition Act, 1937.

5. Registry is directed to list this case along with W.P.No.4184 of 2025 for a final disposal.

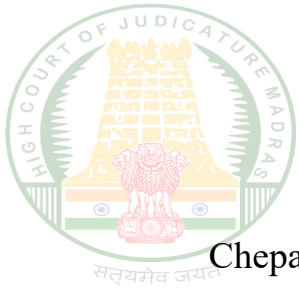
