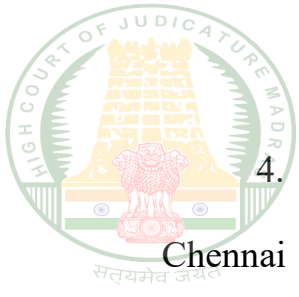

Common Order

Mr.A.M.Packianathan Easter, learned counsel for the petitioner states that the execution proceedings have been laid pursuant to the transmission of the decree by a competent court that has passed a decree in Surat, Gujarat State. The learned counsel for the petitioner also states that the decree was passed more than 10 years back and the petitioner is willing to settle the matter amicably.

2. The learned counsel for the respondent/decree holder, however, states that till date, no proposal has been sent across either to the counsel for the decree holder or to the decree holder company themselves.

3. Considering the submission of the learned counsel for the petitioner that even today, the judgment debtor is willing to amicably settle the matter and the suit being filed only for recovery of money, the parties are referred to the Mediation Centre attached to this court.



4. The authorised representative of the decree holder, who is sitting at Chennai Office, shall be entitled to represent the respondent/decreed holder on appropriate instructions from the Registered Office at Surat. The petitioner shall also appear on 24.09.2026 before the Mediation Centre.

5. Mediation process shall be completed on or before 30.10.2026.

6. Report of the Mediation shall be sent to this court on or before 02.11.2026.

7. List the matter on 04.11.2026.
