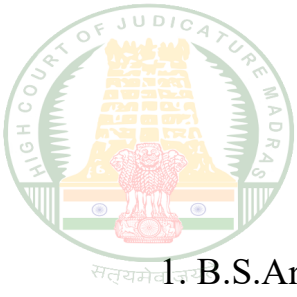

This application is filed by the applicant/mother to grant interim custody

According to the applicant, she is the mother of the minor children and she filed the main petition to appoint her as a guardian to the minor children, Arya Arunkumar and Vrishab Arunkumar, who are now the under the custody of the respondent/father. During the pendency of the application, she want to take custody of her children and spend time with them during the half yearly leave.
