2. There is no appearance for the petitioner today.

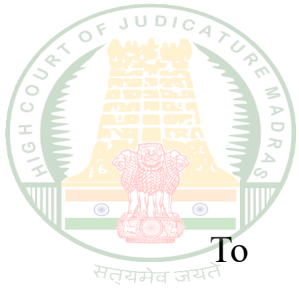
