The relief sought for in the present writ petition is to direct Respondents 1 to 4 to take necessary and appropriate action to remove the encroachments made by the private respondents on the public road situated in S.No.118/7, Alankanatham Privu, Senthamangalam Taluk, Namakkal District, by considering the representations dated 26.12.2022 06.11.2023 06.01.2025 07.03.2025 and 18.08.2025.

2. Learned Additional Government Pleader appearing for R1 to R4, based on the written instructions given by the Tahsildar, Senthamangalam, would submit that Revenue Authorities conducted survey and identified encroachments. Therefore, further action will be initiated for removal of encroachments.

3. In view of the said submission made on behalf of the respondents, respondents 3 & 4 are directed to initiate enforcement action and remove encroachments identified by following procedures as contemplated under the relevant Statute and Rules in force. The said exercise is directed to be completed within a period of twelve weeks from the date of receipt of a copy of this order.
