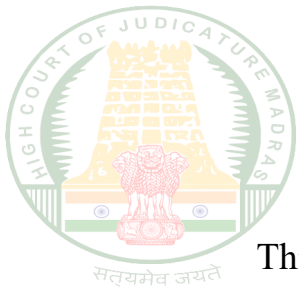

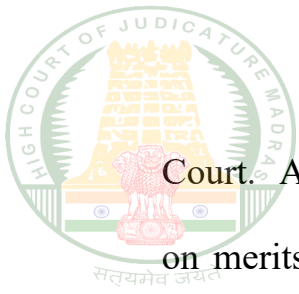
ORDER

This writ petition has been filed seeking for a direction to the third respondent to pass final orders on the petitioner's representation dated 22.07.2023 requesting for cancellation of patta issued in the name of the respondents 4 and 5 pertaining to the property morefully described in the prayer to this writ petition.

2. The petitioner claims that a false patta has been issued in favour of the respondents 4 and 5 for the property morefully described in the prayer to this writ petition. Therefore, he seeks for cancellation of the said patta and has given a representation dated 22.07.2025 to the third respondent for the said purpose. Since the same has not been considered by the third respondent, he has filed this writ petition.

3. Mr.C.Jaya Prakash, learned Government Advocate, accepts notice on behalf of the respondents 1 to 3. Since no adverse orders are passed against the respondents 4 and 5 in this writ petition, notice to the respondents 4 and 5 is dispensed with.

4. No prejudice will be caused to the respondents 1 to 3 if they are directed to pass final orders on the petitioner's representation dated 22.07.2025 on merits and in accordance with law, within a time frame to be fixed by this



Court. Accordingly, this Court directs the third respondent to pass final orders on merits and in accordance with law on the petitioner's representation dated 22.07.2025 seeking for cancellation of patta issued in favour of the respondents 4 and 5 for the property morefully described in the prayer to this writ petition, after issuing notice to the respondents 4 and 5 and hearing their objections, within a period of 12 weeks from the date of receipt of a copy of this order.
