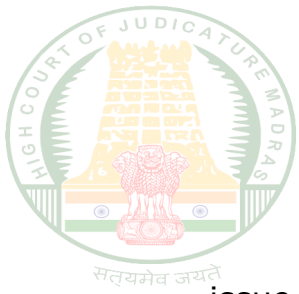

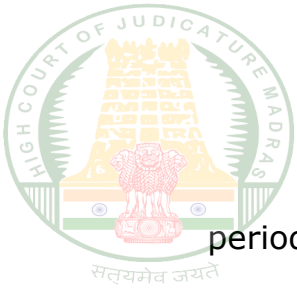

2.The learned counsel appearing for the petitioners submitted

that the first petitioner made representation dated 02.06.2025 to the first respondent seeking sanction of insurance claim under 'police salary package (PSP) – for serving personnel/ employees of Tamil Nadu Police' for the death of his wife and to freeze or place on hold his late wife's savings account and salary account, secure and restrict access to any locker registered in her name and suspend transactions relating to any insurance policies, fixed deposits, or other financial assets linked to her account and the first respondent received the said representation on 04.06.2025, however, there is no response. Hence, this Court may without going into the merits of the case, issue direction to the first respondent to consider the petitioner's representation dated 02.06.2025 and to pass appropriate orders, within a reasonable time frame.

3.Considering the limited relief sought for by the learned counsel appearing for the petitioners, this Court, without expressing any opinion on the merits of the case, directs the first respondent to consider the petitioner's representation dated 02.06.2025, on merits and in accordance with law and to pass appropriate orders, within a
