2. The petitioner is an Employees Co-operative Society. As per the prevailing norms, members of the petitioner should be employees of the 2nd respondent. The members avail loans from the writ petitioner. The repayment of the loans is by deduction of the amounts from their salary.

3. The petitioner states that loan dues from November 2012 and from January 2022 and from January 2025 to October 2025 have not been paid to the petitioner. The petitioner relies upon Section 48 of the Co-operative Societies Act, 1983 to put forth the case of reduction.

4. On account of the failure of the 2nd respondent in not depositing the amounts deducted from the salary of the employees, the petitioner has been put to huge loss & prejudice. Hence, this writ petition.

5. Mr.Muralivinoth shall report as to why the deducted the amounts have not been credited to the account of the writ petitioner.
