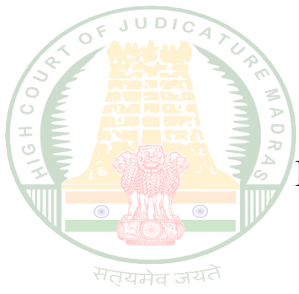

2. Learned counsel for the petitioner undertakes that the case papers will be served on the respondents by today.

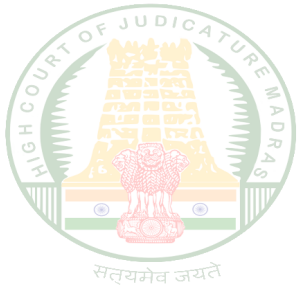
