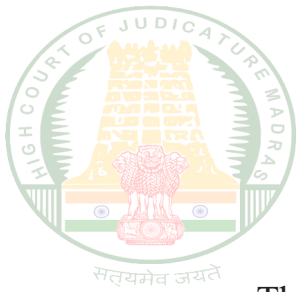

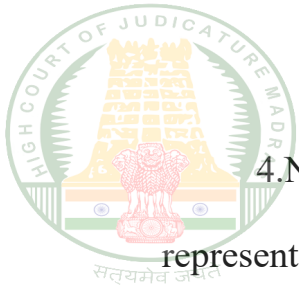
ORDER

This writ petition has been filed seeking for a direction to the respondents to issue a rectified A-Register, chitta and patta for the property more fully described in the prayer to this writ petition in the name of the legal heirs of the petitioner's father late Mr.Gopal, based on the petitioner's representation dated 20.10.2025, within a time frame to be fixed by the Court.

2.The petitioner claims that there is a mistake committed in the A-Register, Chitta and Patta for the property more fully described in the prayer to this writ petition. According to the petitioner, the land has been wrongly classified as 'Annadeenam', whereas the property belongs to the legal representatives of the deceased Gopal. The petitioner seeks for change of classification through his representation dated 20.10.2025. Since the said representation has not been considered till date, the petitioner has filed this writ petition.

3.Mr.D.Ravichander, learned Special Government Pleader accepts notice on behalf of the respondents.



4.No prejudice would be caused to the respondents if the petitioner's representation, as stated supra, is considered, on merits and in accordance with law within a time frame to be fixed by this Court.

5.This Court is not expressing any opinion on the merits of the petitioner's representation.

6.For the foregoing reasons, this Court directs the second respondent to pass final orders, on merits and in accordance with law on the petitioner's representation dated 20.10.2025, seeking to issue rectified A-Register, Chitta and Patta for the property in favour of the legal representatives of the deceased Gopal, for the property more fully described in the prayer to this writ petition, within a period of 12 weeks from the date of receipt of a copy of this order.

7.With the above direction, this writ petition stands disposed of. No costs.
