ORDER

This writ petition has been filed for a mandamus to direct the respondents 1 and 2 to consider the petitioner's representation dated 02.06.2025 seeking for rectification of the extent of the land in the patta for the property morefully described in the prayer to this writ petition. Since the aforesaid representation dated 02.06.2025 has not been considered till date by the respondents, the petitioner has filed this writ petition.

2. Mr.C.Jayaprakash, learned Government Advocate, accepts notice on behalf of the respondents.

3. No prejudice will be caused to the respondents if the petitioner's representation is considered on merits and in accordance with law, within a time limited to be fixed by this Court. Accordingly, this Court directs the first respondent to pass final orders on merits and in accordance with law, on the petitioner's representation dated 02.06.2025 seeking for rectification of her patta for the property morefully described in the prayer to this writ petition, after hearing objections from any neighbouring land owners and any other party, whom the respondents deem fit to enquire, within a period of 12 weeks from the date of receipt of a copy of this order.
