3.There shall be an order of interim stay on condition that the appellant deposits the entire Award amount together with accrued interest and costs to the credit of M.C.O.P.No.725 of 2019, on the file of the Motor Accident Claims Tribunal, Additional District Court (FTC), Kancheepuram within a period of six weeks from the date of receipt of a copy of this order. On such deposit, the Court shall convert the said amount into an interest bearing Fixed Deposit in any Nationalized Bank.
