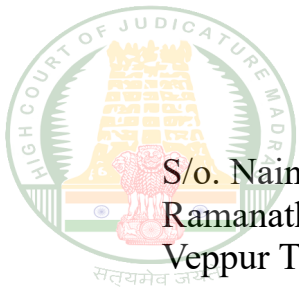

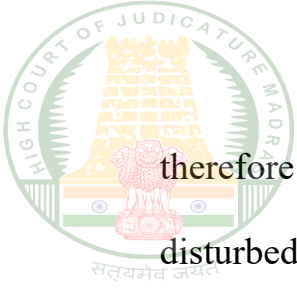

ORDER

Notice to the respondents returnable by 09.01.2026. Private notice is also permitted.

2. Mr.G.Suryanarayanan, the learned counsel for the petitioners submits that the revision petitioners are the legal representatives of the first defendant. Inviting the attention of this Court to the preamble portion of the judgement as well as the preamble portion of the decree, the learned counsel would contend, the suit has been dismissed as against the first defendant. However, the trial Court has erroneously proceeded to include the first defendant while directing delivery of possession in favour of the plaintiff.

2.1. The learned counsel would further submit that even though the Execution Petition has been terminated, it was only on the basis of paper delivery and that the revisions petitioners continue to remain in possession. It is



therefore submitted that the petitioners' possession is now sought to be disturbed and interfered with.
