3. Entertaining an appeal against the notice of motion is unnecessary, since the matter has not been decided on merits. However, we request the writ Court to consider the matter for early disposal.

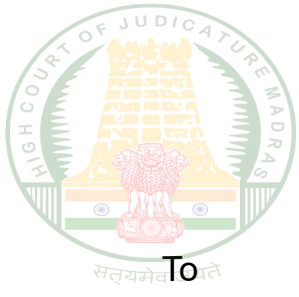
4. Accordingly, this Writ Appeal is **disposed of**. No costs. Consequently, the connected miscellaneous petition stands closed.
