ORDER

Mr.N.Naveenkumar, learned Government Advocate, takes notice for the respondents.

2. The petitioner is the owner of the portion of the property situated in old Survey No.44/1, 45/2 and 46 of Thirumurgan Nagar, Murugamangalam Village, Keerapakkam Village Panchayat, Kattankulathur Panchayat Union, Chengalpattu Taluk & District. The grievance of the petitioner is that over the aforesaid land of which he is the owner, a culvert has been constructed by the respondents. He states that out of the total holdings of 2938 sq.ft an extent of 1688 sq.ft, has been encroached upon. Hence, he before this Court seeking for either removal of the culvert/channel or acquire the land over which the respondents have put up a construction.

3. Mr.N.Naveenkumar, states that the 3rd respondent shall survey the area and submit a report to this Court as to whether the culvert runs over the petitioner's property or it lies entirely within the Government holdings.

4. At the time of inspection and survey, the 3rd respondent shall ensure that the petitioner has put on notice and thereafter, the survey be conducted. The report shall delineate the private holdings of the petitioner from the Government



holdings and also the place where the culvert is constructed.
