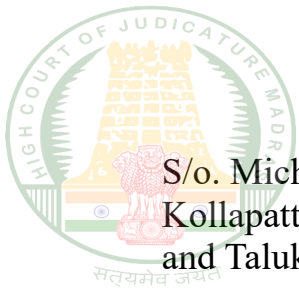

support of the petition and the submissions made by the learned counsel for the



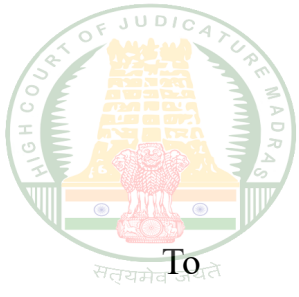
petitioner(s), this Court is inclined to condone the delay, subject to costs.
