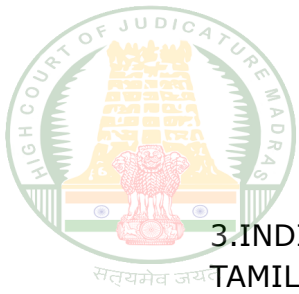

In these writ petitions, the challenge is principally to the voter's list and inclusion of certain voters, in respect of Chennai Division of the Red Cross Society.

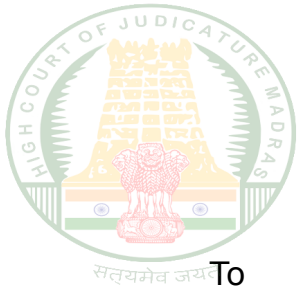
2. Pursuant to the orders of this Court, election was conducted and results have also been declared on 20.12.2025.

3. In view of the aforesaid, at this stage, the relief prayed for cannot be granted. However, it would be open for the petitioners to challenge the election results, in accordance with law, if so advised.

4. With this observations, the writ petitions stand disposed of. There will be no order as to costs. Consequently, WMP Nos.53957, 53154, 53024, 53022 of 2025 are closed.
