As the matter has been rendered infructuous, this habeas corpus petition is closed. No costs.

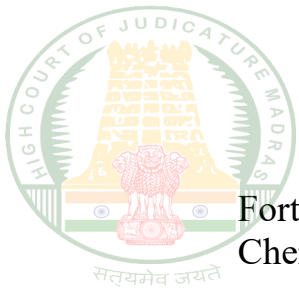
