ORDER

Pursuant to order dated 17.12.2025 permitting the Official Liquidator to effect substituted service on respondents 1 to 3, the Official Liquidator has filed report dated 17.02.2026 enclosing copies of paper publications. Notices were published in the New Indian Express, Chennai edition dated 25.01.2026, the New Indian Express, Bangalore edition dated 25.01.2026 and the New Indian Express, Dharmapuri edition dated 25.01.2026. 2. The Official Liquidator has also stated that an aggregate sum of Rs.2,03,700/- was incurred as expenditure for such purpose.
